TERMS AND CONDITION FOR SUBMISSION OF TENDER

1. Tenders are hereby invited on behalf of the President of India. for the work under Tender cost of **RS. 16,95,377/- (Rs. SIXTEEN LAKHS NINETY FIVE THOUSAND THREE HUNDRED SEVENTY SEVEN) ONLY**
2. Tender document consisting of the detailed plans, complete specifications, the schedule of quantities of the various items of work to be done, and the set of conditions of contract to be complied with by the person whose tenders may be accepted. The tender forms can be downloaded from our website- www.asiagracycircle.in and e-portal eprocure.gov.in from **13/01/2024 to 23/01/2024**.
- 2 (a) The site of the work is available, or the site for the work shall be made available by the department.
1. The Contractors should upload their tender documents online only at CPPP website: <https://eprocure.gov.in/eprocure/app>. upto **15:00 hours of 23/01/2024** which will be opened on dated **24/01/2024 at 15:30 hours**.
2. The time allowed for the work will be **60 days** which will be reckoned after fifteen days from the date of issue of order to commence work.
3. The contractors should quote in figures as well as in words the rate and amount tendered by them. The amount for each item should be worked out and the requisite totals given.
4. When the contractors signs a tender in an Indian Language the percentage above or below and the tendered amount in case of CPWD form No.7 and the total amount tender in the case of CPWD form No.7 and total amount tendered in the case of CPWD form No.8 and should also be written in the same language. In a case of illiterate contractors the rates or the amounts tendered should be attested by a witness.
