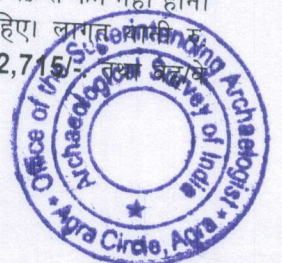

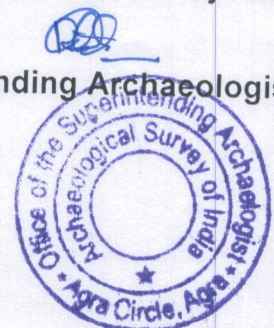

# TERMS AND CONDITION FOR SUBMISSION OF TENDER

1. Tenders are hereby invited on behalf of the President of India, for the work under Tender cost of **THOUSAND EIGHT HUNDRED NINETY FOUR) ONLY** **RS. 6,40,894/- (Rs. SIX LAKHS FORTY**

2. Tender document consisting of the detailed plans, complete specifications, the schedule of quantities of the various items of work to be done, and the set of conditions of contract to be complied with by the person whose tenders may be accepted. The tender forms can be downloaded from our website- [www.asiagrarcircle.in](http://www.asiagrarcircle.in) and e-portal eprocure.gov.in from **25/09/2023 to 03/10/2023**.

3. (a) The site of the work is available, or the site for the work shall be made available by the department.  
The Contractors should upload their tender documents online only at CPPP website: <https://eprocure.gov.in/eprocure/app> upto **15:00 hours of 03/10/2023** which will be opened on dated **04/10/2023 at 15:30 hours**.

4. The time allowed for the work will be **90 days** which will be reckoned after fifteen days from the date of issue of order to commence work.  
5. The contractors should quote in figures as well as in words the rate and amount tendered by them. The amount for each item should be worked out and the requisite totals given.

6. When the contractors signs a tender in an Indian Language the percentage above or below and the tendered amount in case of CPWD form No.7 and the total amount tender in the case of CPWD form No.7 and total amount tendered in the case of CPWD form No.8 and should also be written in the same language. In a case of illiterate contractors the rates or the amounts tendered should be attested by a witness.  
7. Issue of tender form will be stopped one days before the date fixed for opening of tender.

8. Earnest money amounting of **RS. 16,022/- (SIXTEEN THOUSAND TWENTY TWO ONLY)** (unless exempted) in deposit at call received/FDR of scheduled bank guaranteed by the Reserve Bank of India must accompany each tender.  
9. The contractor whose tender is accepted (unless exempted) will be required to furnish by way of security deposit for the due fulfillment of his contract.

14. 16. All rates shall be quoted on the proper form of the tender alone.  
17. The criteria for approval of the lowest tender is over all lowest one against the total cost of the tender amount of all tenders.

18. On acceptance of the tender, the name of the accredited representative(s) of the contractor who would be responsible for taking instructions from the Engineer in charge shall be communicated to the Engineer in charge.  
19. Special care should be taken to write the rates in figures as well as in words and the amounts in figures only, in such a way that interposition is not possible. The total amount should be written both in figures and words. The case of figures, the word Rs. should be written before rupees and word (P) after the decimal figures e.g. 2.15 p and case of words the word (Rupees) should proceed and the word 'only' it should in variably upto decimal places. While quoting the area in the schedule of quantities the word only should be written closely following the amount and it should not be written closely following the amount and it should not be written in the next line.

20. The President of India does not bind himself to accept the lowest or any tender and reserves to himself the right of accepting the whole or any part of the tender and tenderer shall be bound to perform the same at the rates quoted.  
21. GST or any other or material in respect of this contracts shall be payable by the contractor and Government will not entertain any claim whatsoever in this respect.

22. 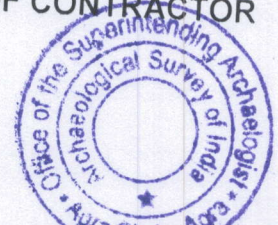

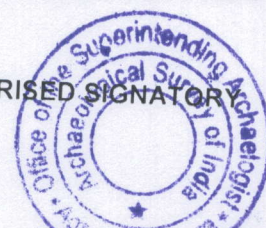

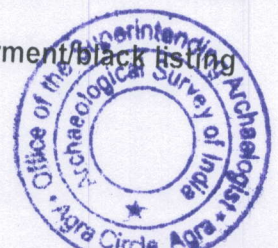

  - 2) As part of the enrolment process, the Bidders will be required to choose a unique username and assign a password for their accounts.
  - 3) Bidders are advised to register their valid email address and mobile numbers as part of the registration process. These would be used for any communication from the CPP Portal.

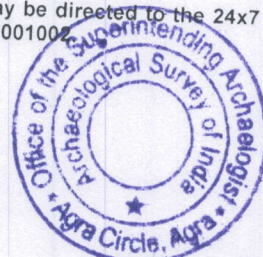

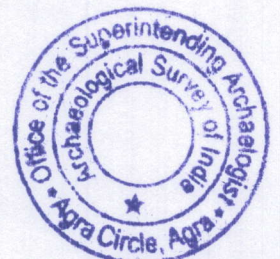
