## TERMS AND CONDITION FOR SUBMISSION OF TENDER

2. Tender document consisting of the detailed plans, complete specifications, the schedule of quantities of the various items of work to be done, and the set-of conditions of contract to be complied with by the person whose tenders may be accepted. 14-Special care should be taken to write the rates in figures as well as in words and the amounts in figures only, in such a way that interposition is not possible.
