

TERMS AND CONDITION FOR SUBMISSION OF TENDER

1. Tenders are hereby invited on behalf of the President of India. For the work under Tender cost of **RS. 19,15,555/- (Rs. NINETEEN LAKHS FIFTEEN THOUSAND FIVE HUNDRED FIFTY FIVE ONLY)**
2. Tender document consisting of the detailed plans, complete specifications, the schedule of quantities of the various items of work to be done, and the set of conditions of contract to be complied with by the person whose tenders may be accepted. The tender forms can be downloaded from our website- www.asiagraticircle.in and e-portal eprocure.gov.in from **26/07/2023 to 10/08/2023**.

2 (a) The site of the work is available, or the site for the work shall be made available by the department.

2. The time allowed for the work will be **180 days** which will be reckoned after fifteen days from the date of issue of order to commence work.

4. 12. The criteria for approval of the lowest tender is over all lowest one against the total cost of the tender amount of all tenders.
13. On acceptance of the tender, the name of the accredited representative(s) of the contractor who would be responsible for taking instructions from the Engineer in charge shall be communicated to the Engineer in charge.
14. Special care should be taken to write the rates in figures as well as in words and the amounts in figures only, in such a way that interposition is not possible.
