## TERMS AND CONDITION FOR SUBMISSION OF TENDER

2. Tender document consisting of the detailed plans, complete specifications, the schedule of quantities of the various items of work to be done, and the set of conditions of contract to be complied with by the person whose tenders may be accepted. The tender forms can be downloaded from our website- WWW.asiagracircle.in and eportal eprocure.gov.in from 15/09/2022 to 23/09/2022.

2 (a) The site of the work is available, or the site for the work shall be made available by the department.
