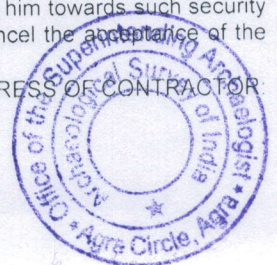


### TERMS AND CONDITION FOR SUBMISSION OF TENDER

1. Tenders are hereby invited on behalf of the President of India. For the work under Tender cost of **RS. 12,78,620/- (Rs. TWELVE LAKHS SEVENTY EIGHT THOUSAND SIX HUNDRED TWENTY ONLY)**
  2. Tender document consisting of the detailed plans, complete specifications, the schedule of quantities of the various items of work to be done, and the set of conditions of contract to be complied with by the person whose tenders may be accepted. The tender forms can be downloaded from our website- [www.asiagracycircle.in](http://www.asiagracycircle.in) and e-portal [eprocure.gov.in](http://eprocure.gov.in) from **22/02/2024 to 13/03/2024**.
  - 2 (a) The site of the work is available, or the site for the work shall be made available by the department.
  1. The Contractors should upload their tender documents online only at CPPP website: <https://eprocure.gov.in/eprocure/app>. **up to 15:00 hours of 13/03/2024** which will be opened on dated **14/03/2024 at 15:30 hours**.
  2. The time allowed for the work will be **150 days** which will be reckoned after fifteen days from the date of issue of order to commence work.
  3. The contractors should quote in figures as well as in words the rate and amount tendered by them. The amount for each item should be worked out and the requisite totals given.
  4.   12. The criteria for approval of the lowest tender is over all lowest one against the total cost of the tender amount of all tenders.

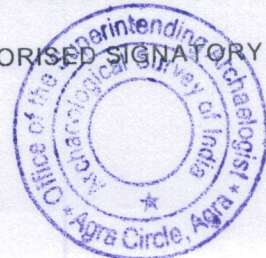

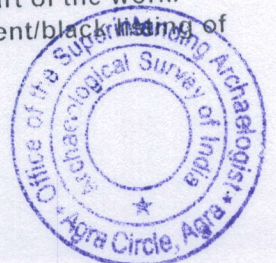

- 2) As part of the enrolment process, the Bidders will be required to choose a unique username and assign a password for their accounts.
- 3) Bidders are advised to register their valid email address and mobile numbers as part of the registration process. These would be used for any communication from the CPP Portal.

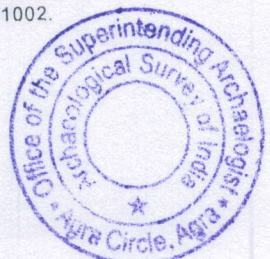
