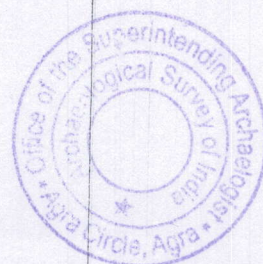

TERMS AND CONDITION FOR SUBMISSION OF TENDER

1. Tenders are hereby invited on behalf of the President of India. For the work under Tender cost of **RS. 11,84,124/- (Rs. ELEVEN LAKHS EIGHTY FOUR THOUSAND ONE HUNDRED TWENTY FOUR ONLY)**
2. Tender document consisting of the detailed plans, complete specifications, the schedule of quantities of the various items of work to be done, and the set of conditions of contract to be complied with by the person whose tenders may be accepted. The tender forms can be downloaded from our website- www.asiagracycircle.in and e-portal eprocure.gov.in from **21/09/2023 to 16/10/2023**.
- 2 (a) The site of the work is available, or the site for the work shall be made available by the department.
1. The Contractors should upload their tender documents online only at CPPP website: <https://eprocure.gov.in/eprocure/app> upto **15:00 hours of 16/10/2023** which will be opened on dated **17/10/2023 at 15:30 hours**.
2. The time allowed for the work will be **240 days** which will be reckoned after fifteen days from the date of issue of order to commence work.
3. The contractors should quote in figures as well as in words the rate and amount tendered by them. The amount for each item should be worked out and the requisite totals given.
4. When the contractors signs a tender in an Indian Language the percentage above or below and the tendered amount in case of CPWD form No.7 and the total amount tendered in the case of CPWD form No.8 and should also be written in the same language. In a case of illiterate contractors the rates or the amounts tendered should be attested by a witness.
5. Issue of tender form will be stopped one days before the date fixed for opening of tender.

13. On acceptance of the tender, the name of the accredited representative(s) of the contractor who would be responsible for taking instructions from the Engineer in charge shall be communicated to the Engineer in charge.
14. Special care should be taken to write the rates in figures as well as in words and the amounts in figures only, in such a way that interposition is not possible. The total amount should be written both in figures and words. The case of figures, the word Rs. should be written before rupees and word (P) after the decimal figures e.g. 2.15 p and case of words for the word (Rupees) should proceed and the word 'only' it should be written variably up to decimal places. 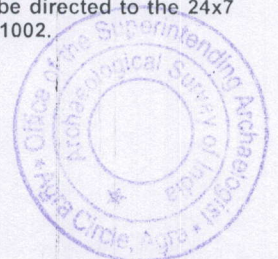
